## Parental Consent Form

### 1. INTERNET ACCESS Acceptable Use Agreement

As part of the school's ICT programme we offer pupils supervised access to the Internet. In order to reduce the risk of accidentally accessing inappropriate material, the school employs a service provider that prevents access to listed undesirable sites. However, no system is fool proof. As your child gets older we will expect them to take increasing responsibility for safe use of the internet. We require your written permission for your child to have access to the Internet.

### 2. VISITS TO LOCAL DESTINATIONS
